Studies suggest, however, that these hazards are not associated with other routes of exposure. Since this product is in a liquid/paste form, none of these components are able to become airborne and cannot be inhaled. Thus, the hazards usually associated with Quartz, Carbon Black, or Titanium Dioxide are not applicable to this product.
